## Former Assistant U.S. Attorney Ross E. Morrison Joins

He also clerked for the Honorable Shira A. Scheindlin of the Southern District of New York after graduating cum laude from Harvard Law School and has served as an adjunct professor at Fordham and Cardozo Law Schools.
