In these roles, Jason investigated, prosecuted and/or supervised a wide variety of complex cases involving racketeering, homicide, organized crime, labor union corruption, and gang-related and drug-related violence, international and domestic narcotics trafficking, sex trafficking, fraud, and firearms offenses.

Jason began his legal career as an Assistant Attorney General in the Massachusetts Attorney General's Office and then as an associate at Shearman & Sterling LLP. While at Shearman and Sterling, he was part of the trial and appellate team that secured the reversal of a hedge fund manager's insider trading conviction and dismissal of the indictment, as well as the vacatur of a

state inmate's death sentence.
