Zoom Mediations Yield Positive Results and Happy, Satisfied Clients

With the courts closed down in the spring and re-opening at a measured pace, Yankwitt LLP has continued to successfully advance its cases using mediations conducted via Zoom. Here are four standout matters with outstanding results.

- Yankwitt LLP represented a Los Angeles-based global entertainment company in a cyber breach case filed against an
 accounting firm. Our aggressive complaint followed by our assertive mediation statement and negotiating efforts led to a
 favorable monetary settlement for our client without the need for litigation.
- Yankwitt LLP represented directors of a senior housing facility in a suit filed by the plan administrator and approximately 100 former residents alleging breach of fiduciary duty and financial disclosure obligation. The demand was \$50 million, but we were able to settle the case for a fraction of that, fully paid by the insurance company and with releases for our clients.
- Yankwitt LLP represented a Fortune 500 company in a product liability suit with a demand of \$5 million. The mediation resulted in a settlement, of which our client paid less 5% of the demand.
- Yankwitt LLP represented a foreign nonprofit organization in affirmative litigation against the company's former law firm, asserting claims for excessive billing in prior litigations. At the mediation, the law firm agreed to reimburse a significant portion of the legal fees.
